SOAH Prelim sets Contested Case Hearing Date

Monday, April 6th The State Office of Administrative Hearings (SOAH), an independent agency tasked with presiding over hearings for state agencies, conducted a preliminary hearing in Austin with regards to the application by Post Oak Clean Green, Inc. to TCEQ to obtain a permit to build a municipal solid waste landfill over the outcrop of the Carrizo-Wilcox aquifers in Guadalupe County.

The Preliminary hearing determined the parties of interest that will participate in the contested case hearing set to take place **January 4, 2016**. Those parties include: the applicant, Post Oak Clean Green, Inc., TCEQ Public Interest Council, TCEQ Executive Director, The Cities of Schertz and Seguin, Guadalupe County, Schertz-Seguin Local Government Corporation (SSLGC), Citizens group Stop Post Oak Dump (SPOD), citizen Kathy Brady, and of course Guadalupe County Groundwater Conservation District (GCGCD).

Site of Proposed Landfill

If built and operated as anticipated, the proposed municipal landfill will ultimately hold 87 million cubic yards of compressed waste, piled some 232 feet high, resting on a thin poly liner only 1/16" thick just 20 feet above the aquifer that supplies drinking water to potentially hundreds of thousands of people as well as livestock and agriculture uses.

The site, to be located off FM 1150 approximately 12 miles outside Seguin, is in the outcrop area of the Carrizo-Wilcox aquifers. Water, primarily rainfall and runoff from streams and rivers enters the aquifer at this recharge location. With many old abandoned oil and gas wells on the site - coupled with the potential for the thin liner to eventually fail, the risk of waste infiltrating the sole water source for multiple cities is too great. For that reason, several entities have joined the TCEQ contested case hearing proceedings seeking party status to attempt to stop Post Oak Clean Green, Inc. from attaining the necessary permits and ultimately building this solid waste facility over the precious resource so many are dependent upon to survive.

Presently, the affected parties are reviewing the Response to Comments (RTC's) that were submitted. At the conclusion of the SOAH hearing, scheduled to take place at the start of next year, the judges will submit a proposal of their decision to the TCEQ for formal consideration. The commissioners then approve, deny, or modify the proposal for decision. For more information on contested case hearings visit the TCEQ website.

District 3 – Donegan Resigns – New Appointee


